## Fourth Transnational Partners Meeting

GreenVET4U partners recently gathered in Milan, Italy, for the 4th Transnational Partners Meeting, hosted by Centro Servizi Formazione (CSF). Over three days, the consortium reviewed progress, coordinated upcoming activities, and advanced joint work on innovative curricula, digital tools, and micro-credentials for green skills.

The meeting also included a study visit to CSF's training centre in Vigevano, offering valuable insights into real VET practices and how training provision can better respond to labour market needs.

## Competence matrix for designing green VET curricula

One of GreenVET4U's key project results is now available: the Competence Matrix on Design and Delivery of Innovative Curricula in Skills for Green Jobs. This practical and structured tool defines the competences VET practitioners and in-company trainers need to design training aligned with Uganda's green transition.

Built around six strategic competence areas, the matrix provides clear learning outcomes and performance criteria, making it a concrete resource for curriculum design, capacity building, and quality assurance.

In addition, the matrix is designed as a flexible and transferable reference tool, suitable both for developing new training programmes and for reviewing and improving existing ones. Its alignment with levels 5 and 6 of the European Qualifications Framework supports its use across different professional profiles, from technical trainers to staff with coordination and management responsibilities. In this way, the Competence Matrix helps VET professionals create coherent, relevant training pathways that enhance employability and contribute to sustainability within the green economy.
